Executive Summary:

Since their inception in 1932, the Kinsmen Club of Kingston has been a small group of dedicated volunteers who strive to serve our "Community's Greatest Need". The annual Kinsmen Dream Home Lotto has helped serve those needs for 33 years, by directing 100% of the funds raised for the lotto ticket sales towards other local charitable organizations. In 2023, the Kinsmen Club of Kingston allocated over \$692,000 to 16 local charities.

Along with builders, sponsors and community support, Kinsmen is able to offset the cost of building the dream home, as well as runner-up prizes.

The 2025 Kinsmen Dream Home is being built in partnership with Tamarack Homes. The City of Kingston has received a formal request from the Kinsmen Club of Kingston for a contribution to the 2025 Kinsmen Dream Home project in an amount equivalent to the development charges

paid for the project, being \$37,991.90. Through this contribution, the Kinsmen Club of Kingston can reallocate the development charges paid to an eligible local charity.

Staff are recommending to Council that a contribution equivalent to the amount of the development charges for the project be issued to the Kinsmen Club of Kingston from the Working Fund Reserve.

Recommendation:

That Council direct staff to make a contribution of \$37,991.90, equivalent to the amount of development charges paid for the project, from the Working Fund Reserve to the Kinsmen Club of Kingston for the 2025 Kinsmen Dream Home project, for the purposes of the Kinsmen Club of Kingston reallocating these funds to an eligible local charity; and

That Council direct staff to report back with information on donations once the Kinsmen Club of Kingston has allocated funding to community organizations.

Options/Discussion:

Since its founding, Kin, Kinsmen and Kinette clubs across Canada have contributed more than \$1 billion to Canadian communities and disaster relief programs beyond our borders.

Since their inception in 1932, the Kinsmen Club of Kingston has been a small group of dedicated volunteers who strive to serve our "Community's Greatest Need". The City of Kingston has received a formal request from the Kinsmen Club of Kingston for a contribution to the 2025 Kinsmen Dream Home project in an amount equivalent to the development charges paid for the project. Payment of this contribution will allow the Kinsmen Club of Kingston to reallocate the development charges paid to an eligible local charity. Staff are recommending to Council that the contribution, in the amount of \$37,991.90, be issued to the Kinsmen Club of Kingston, for reallocation to a local charity.

Staff also intend to continue to work with the Kinsmen Club of Kingston to identify other ways to partner and better support community associations and agencies in future years.
