Options/Discussion:

Background

The Housing and Homelessness Advisory Committee (HHAC) provides City Council advice regarding policies, directives and strategies related to housing and homelessness. To assist HHAC members in their understanding of work-related activities, staff bring forward a work plan with proposed work items each year.

To ensure that the feedback of HHAC members is included in the 2025 work plan, staff are bringing forward this report to allow members the option to provide input. It will also allow for discussion on Kingston's Strategic Plan 2023-2026 ('the Plan') to ensure alignment with housing-related items identified within the five core pillars of the Plan. The Plan's web page allows members of the public to view real-time tracking of the progress on each of the five pillars of the Plan.

Below is a list of some key initiatives identified under the first pillar (Support Housing Affordability) that staff would welcome committee advice and feedback on:

1.1 Promote increased supply and affordability of housing

- 1.1.1 Seek opportunities to foster innovative approaches to housing
 - Explore the development of programs with housing partners that help improve the credit worthiness of renters
 - Implement innovative partnerships for affordable housing such as head leases
- 1.1.5 Ensure growth planning strategies support/enable the equitable distribution of housing types across the City
 - Update the affordable housing locational analysis

1.2 Promote increase in purpose-built rental housing

- 1.3 Increase supply of new-build not-for-profit and co-op housing and ensure sustainability and quality of existing stock
- 1.3.1 Advocate for provincial and federal support to build new not-for-profit and co-op housing
 - Work with housing providers to leverage both provincial and federal funding opportunities
- 1.3.2 Develop a strategy for the 'wind up' of existing operating agreements and renewal of assets

1.4 Improve service to unhoused and precariously housed

- 1.4.1 Continue to support partners in implement integrated solutions for vulnerable and unhoused populations
 - Facilitate and support the development of specialized care facilities with a focus on youth, single adults, families and health
